**Pursuant to** the United States of America Republic Constitution **Amendment 19, Section 2, Clause 2**, wherein it states; “ **The United States of America Republic** shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States of America Republic, or any Department or Officer thereof”, there shall hereby be designated “**Repatriation is a Baptism and Rebirth**” provisions to serve this purpose. This Executive Order shall go into immediate force.

**Introduced** as Executive Order 119-73, a request was delivered by the President to honor and therefor establish protocols for our “Repatriation is a Baptism and Rebirth”.

**The Executive Order** suffered no amendments, no exclusions, and no demands, that it has now been entered into full force.

**The 1st Continental** Congress of the United States of America Republic publicly declared 2015 the national “Year of the United States of the United States of America Republic”. The document known as Executive Order 119-73 was signed and enacted into law on 4 June 2020 by the President. The Executive Order has been delivered to the Secretary of State in Attendance;

**EXECUTIVE ORDER 119-73 on 6 June 2020**

**The President**, Authorizing and Requesting To proclaim and establish provisions in accordance with the Constitution and Laws of the United States of America Republic.

NOW, THEREFORE, be it Resolved by the President of the United States of America Republic, The President has authorized and requested to designate the administration of said Executive Order 119-73.

## **“Repatriation is a Baptism and Rebirth”**

### **Executive Order #119-73**

**REPATRIATION IS A RE-BIRTH AND HE/SHE SHALL BE BORN/REBORN AGAIN  
INTO THE KINGDOM OF GOD**

#### **BODY OF LAW**

All Moorish Americans shall Repatriate and it shall be as a Re-Birth and he/she shall be born again into the Kingdom of God, a new birth certificate shall be proof of being born of water and of spirit, no Moorish American shall be born of the flesh, but only of the spirit. The issuing and receiving of a **U.S.A.R. Birth Certificate** Therefore brethren, Moorish Americans are debtors not to the flesh, to live after the flesh: For if ye live after the flesh, ye shall die, but a **U.S.A.R. Birth Certificate** shall mortify any Birth Certificate issued by any state the deeds of the body by the Spirit, ye shall live. For as many as are led by the Spirit of God, they are the sons of God. For Moorish Americans have not received the Spirit of bondage, to fear again: but ye have received the Spirit of the One Most High and the Europeans by adoption, whereby we cry, Abba, Father. The same Spirit bear witness with our spirit, that we are the children of God.

Except a Moorish American man/Woman be born again, he/she cannot see the kingdom of God. Except that a Man/Woman is born of water and of the Spirit, he cannot enter into the kingdom of God. Moorish Americans that are born of the flesh, is flesh: and that is born of the Spirit, is spirit.

#### **Definitions;**

**The term Flesh** means: 1) State Birth Certificate 2) A Birth Certificate issued by anyone of the 50 Continental state governments 3) A Birth Certificate issued by the U.S. Federal government 4) a Bank Note issued by a foreign owned bank.

**The term Birth** means: 1) Baptism, 2) to be born or to give rise

**The term U.S.A.R. Birth Certificate** means: 1) Bond 2) U.S.A.R. Obligation 3) Spirit, 4) Fee Simple Absolute Title 5) a parcel of land 40 acres



**The term Repatriation means:** noun 1. The return of someone to their own country.  
"The voluntary repatriation of refugees" 2. The sending of money back to one's own country.  
"The repatriation of profits by foreign investors"

**The term Baptism means:** In Islamism the religious rite of sprinkling water onto a person's forehead or of immersion in water, symbolizing purification or regeneration and admission to the Moorish American Moslem Faith. In many denominations, baptism is performed on young children and is accompanied by name-giving. a ceremony or occasion at which baptism takes place. Plural noun: baptisms a person's initiation into a particular activity or role, typically one perceived as difficult. This event shall constitute his or her baptism as being an "Ordained Moslem politician"

Marvel not that I said to thee, Ye must be born again. The wind bloweth where it will, and tho you hear the sound thereof, but cannot tell where it comes, and where it goes: so is every Moorish American that is born of the Spirit.

Verily, verily I say unto thee, We speak that we know, and testify that we have seen: but ye receive not our witness. If when I tell you earthly things, ye know not, how should ye know, if I shall tell you of heavenly things? For God sent not his Son into the world, that he should condemn the world, but that the world through him might be saved. He that believeth in him, is not condemned: but he that believeth not, is condemned already, because he hath not believed in the Name of that only begotten Son of God. And this is the condemnation, that light came into the world, and men loved darkness rather than that light, because their deeds were evil.

God is not the God of the dead, but the God of the living. Ye are therefore greatly deceived. For every man that evil doeth, hateth the light, neither cometh to light, lest his deeds should be reprov'd. But he that doeth truth, cometh to the light, that his deeds might be made manifest, that they are wrought according to God.

But Jesus perceived their wickedness, and said, Why tempt ye me, ye hypocrites? Show me the tribute money. And they brought him a penny. And he said unto them, Whose is this image and superscription? They said unto him, Caesar's. Then said he unto them, Give therefore to Caesar, the things which are Caesar's, and give unto God, those things which are God's.

FOR MOORISH AMERICANS ARE BORN OF THE LIGHT, LET THOSE OF THE LIGHT, COME TO THE LIGHT FROM THE DARKNESS OF THEIR MOTHERS WOMB TO ENFORCE THE LAW. ALL MOORISH AMERICAN CHILDREN BORN AND ANY ADULT RE-BORN UPON REPATRIATION ARE THE PROPERTY OF THE ONE MOST HIGH AND SHALL BE THE INHERITANCE OF THE CREATOR AND THEIR CHILDREN SHALL BE, THE HEIRS OF THE KINGDOM OF GOD. HE WHO IS BORN OF GOD DOES NOT BREAK THE LAW, FOR THE SEED OF THE FATHER REMAIN IN HIM/HER AND THEY SHALL NOT BREAK THE LAW BECAUSE THEY ARE BORN OF GOD. IN THIS THE MOORISH AMERICANS ARE MANIFEST. THEY SHALL PRACTICE LOVE AND NOT HATE, THEY SHALL PASS ON FROM DEATH INTO LIFE. THOSE THAT DO NOT LOVE THEIR BROTHER OR SISTER BIND THEIR SOUL'S TO ETERNAL DEATH. THOSE WHO HATE THEIR BROTHER OR SISTER ARE MURDERS AND HAVE NO ETERNAL LIFE IN THEM. THOSE THAT UPHOLD AND KEEP THE CONSTITUTION OF THE UNITED STATES OF AMERICA REPUBLIC HAVE BECOME ONE WITH GOD AND HE WITH THEM. THIS IS THE LAW OF GOD AND THE REUNION OF FATHER MOTHER AND CHILD.

The Europeans call us dead and say that when Jesus died on the cross they also died and when Christ was raised by the Father they too was also raised. Now the Europeans say to themselves that they now live in spirit. The Europeans teach that we Moorish Americans are dead because we are under the law being circumcised we are debtors to uphold the whole law. That we Moorish Americans being apart of the promise. Whom the Most High has given his oracles too, are a dead people under the law.

The Europeans believe that through faith they live. I say to the Europeans Faith without works is dead. The Europeans have deceived themselves.

Then Jesus answered, and said unto them, are ye not therefore deceived, because ye know not the Scriptures, neither the power of God.

For when they shall rise again from the dead, neither men marry, nor wives are married, but are as the Angels which are in heaven. And as touching the dead, that they shall rise again, have ye not read in the book of Moses how in the bush God spake unto him, saying, I am the God of Abraham, and the God of Isaac, and the God of Jacob? God is not the God of the dead, but the God of the living. Ye are therefore greatly deceived.

So then Negro, Black and African Americans are in the flesh, and cannot please God. Now ye Moorish Americans are not in the flesh, but in the Spirit, because the spirit of God dwelleth in you: but if any Moorish American hath not the Spirit of the Most High, the same is not theirs. And if the Most High be in you, the body is dead, because of sin: but the Spirit is life for righteousness sake. But if the Spirit of him that raised up Jesus from the dead, dwell in you, he that raised up Christ from the dead, shall also quicken your mortal bodies, by his Spirit that dwelleth in you. Therefore brethren, we are



debtors not to the flesh, to live after the flesh: For if ye live after the flesh, ye shall die: but if ye mortify the deeds of the body by the Spirit, ye shall live. For as many as are led by the Spirit of God, they are the sons of God. For ye have not received the Spirit of bondage, to fear again: but the Europeans through Our brother Christ have received the Spirit by adoption, not all Europeans, only those who are the true followers of Christ whereby we cry, Abba, Father. The same Spirit beareth witness with our spirit, that we are the children of God. Therefore We Moorish Americans Live! Moorish Americans In repatriating, you obtain resurrection from the dead.

### The Dead Baby Scam.

The British Territorial Service Providers set up a Public Charitable Trust for the welfare relief of Moorish Americans, who were labeled and branded with the misnomer names as Negro, black and Colored. The true American Nationals whom worked Plantations and were displaced by the American Civil War.

They conscripted American doctors, nurses, and dentists under Color of Law and imposed licensing regulations on them as if they were legitimately British Territorial Citizens, using their own Uniformed Officers Code, and coercing civilians to comply under false pretenses.

Next, they required these conscripts to falsify hospital records in such a way as to make it appear that all the women giving birth were unwed Mothers. According to them, all the babies born in America are born without Fathers— which would amount to millions of illegitimate children and not a married woman in the whole country, including Moors.

Next, they imposed upon these women to unknowingly donate their babies as wards of the British Territorial Government franchises operating as States of States organizations. This is done by importuning them to sign undisclosed private contracts, making it appear that all these purportedly unwed mothers were voluntarily surrendering unwanted children to the mercy of the British King.

Like the Arbitration Award Scam, this results in the victims being trafficked off their native soil and into the international jurisdiction of the sea, where they are misidentified as wards of the British United States Territorial commonwealth administered by the British Monarch. The British Monarch then splits the take with the Pope's other business operation, the Municipal United States Government.

In this manner, both the British Monarch and Pope got their hooks into Moorish Americans who are owed their Good Faith Service, instead of their malicious chicanery.

The victim's assets are then dumped into the Public Charitable Trust (PCT) created for the welfare relief of displaced plantation workers—and administered under Dead Letters of Administration issued by Territorial Courts to members of the British Bar Association. So the Pope hires the King and the King hires the Bar Associations to do the dirty work in the field, and all this criminality runs rampant in the international jurisdiction of the sea without a single hand or voice being raised in behalf of the suffering people of this planet, most of whom have been mis-represented in the same manner.

A third example of the depravity, criminality, Bad Faith, and incompetence of these erstwhile Federal Service Providers is found in the so-called Internal Revenue Service established by the British Territorial United States Government doing business in our names as "the" United States of America, and the IRS, a municipal corporation established by the Municipal United States Government, ostensibly to collect taxes from persons who were legitimately either United States Citizens or Municipal citizens of the United States.

The operations of these two separate but similarly named entities exist to collect taxes on income earned by actual Municipal and Territorial Corporations and Federal Employees, both British Territorial United States Citizens and their dependents in the military, and Municipal United States citizens and their dependents operating in various capacities.

NO Moorish American National or American State Citizen was ever legitimately subject to an income tax on their earnings, wages, salaries, business profits, or other gain from honest employment of any kind, but by various means of constructive fraud and undisclosed contracting processes the offending Federal Service Providers contrived to evidence false claims and extort income taxes from Moorish American Nationals and American State Citizens under color of law and pretense of valid private contract.

In the case of the Territorial United States Government, the basis for these false claims were primarily established via The Dead Baby Scam\_ In the case of the Municipal United States, the basis for these false claims were based on purportedly "voluntary" participation in Federal Social Security programs that are not supposed to be available to the Public, and upon hidden novation contracts embedded in the 1040 Tax Forms people filled out and also upon their innocent participation in The Victory Tax Program adopted by the Municipal United States Congress during World War II.

Suffice it to say that average Americans are not organized as Personal Corporations and do not accrue federal corporate income, did not voluntarily nor knowingly create any intestate infant decedent estate nor donate any such thing



to any Public Charitable Trust, did not willingly participate in the Municipal Government's pension program known as Social Security, were not the Parties being addressed when Franklin Delano Roosevelt "consecrated" the Municipal United States Government as a religious cult during his First Inaugural Address, and are not rendered "citizens" of either one of these foreign Federal Service Providers as a result of obeying what they believed were legitimate demands made upon them by Undeclared Foreign Agents improperly exercising positions of delegated authority and trust

As a result, both these organizations, the Internal Revenue Service and the IRS, have been collecting billions of dollars-worth of taxes under False Pretenses and under Color of Law, from people who are actually their Employers and who are not subject to any such tax.

Again, we find that the Pope and the Roman Curia and their gross misadministration of Government Services Corporations, both Territorial and Municipal, are responsible for this criminality.

Even upon a diligent review of the circumstance we can find no plausible excuse for this behavior and these viciously enforced legal presumptions, beyond criminal and self-interested motives. Millions of innocent Moorish Americans have been preyed upon by these Territorial and Municipal corporations, both ultimately operated by the Roman Catholic Church— which has been grotesquely misusing the powers delegated and entrusted to these Principals under the terms of the Constitutions allowing them to be on our soil in the first place\_\_

Mr. Charles Rettig, Commissioner in charge of these foreign tax agencies, is hereby served Notice that no debts are to be alleged and no income taxes are to be collected from any Moorish American Nationals or American State Citizen. No liens against our property assets neither public nor private are to be established or maintained against our names or any abbreviation, permutation, ordering, punctuation, variation or combination of names, now or at any time in the future. American State Nationals and American State Citizens are exempt from all such non-domestic (with respect to us) taxes, tariffs, and fees. All improper collection processes must immediately cease and desist, and all fraudulent liens, garnishments, and similar actions must be released. Living people and Lawful Persons are exempt and corporations issued in our Names/NAMES are tax pre-paid.

The only persons subject to Federal Income Taxes are actual Federal Employees and their Dependents, and that is a private obligation resulting from their employment with these Foreign Service Providers\_\_

No unconscionable contract resulting from The Dead Baby Scam, and no other contracts lacking full disclosure, such as the Arbitration Award Scam, will be honored anywhere in this National Republic. Any attempt to improperly allege or collect Federal taxes or State of State franchise taxes so as to seize upon the property assets of Moorish America Nationals or American State Citizens will be recognized as criminal trespass upon private property, racketeering, attempted unlawful conversion of assets, and attempted inland piracy. We hold the Pope and the Queen ethically and commercially responsible for properly directing and informing their employees to avoid all such criminal trespasses and criminal activities

Constructive foreclosure fraud by the municipal commercial banks is yet another example of lawless predatory behavior on the part of our Service Providers and their interlocking trust directorate. Millions of Americans have been evicted from their homes and other properties as a result of non-disclosed contracts and deceitfully misrepresented lending practices. Many more Americans have paid mortgages that they never owed.

We, The United States of America Republic, bring our Decree Over Mandate before the face of Pope Francis, as he and his Predecessors are the owners of and have oversight as the actual operators of both the British Territorial Commonwealth and the Municipal United States Government. Clearly, they have colluded in conspiracy to overturn and make a mockery of our Constitutional and Treaty Agreements and have evaded their own settled obligations and moral duties. We, The United States of America Republic, bring these issues before the face of the Vatican Chancery Court in the Person of Cardinal H.E. Cardinal Dominique Mamberti and before Pope Francis in the presence of these Witnesses and issue our Decree Over Mandate established by the various Constitutions and international treaties owed to us: we demand that these afore-described and all similar criminal activities, Misrepresentations, and self-serving Legal Presumptions and Practices executed under the Rule of Law in avoidance of the Law, immediately and permanently — cease. By so doing, we do not offer to subject ourselves to the Vatican Chancery Court and are instead forcing it to observe its own duty in public.

We, The United States of America Republic, want the world to know what kind of Business Partners and Allies the Popes and the British Monarchs have proven to be, and we want them exposed as the driving forces behind enslavement of our people, manipulation of world commodity markets, and perpetual war for profit. Obviously, the Popes and the British Monarchs have been secretively acting as criminals and playing both ends against the middle for decades while the rest of us slept on, trusting them to do the right thing.

We, The United States of America Republic, bring these issues before the face of the Prosecutor of the international Criminal Court and before the faces of the



Justices of the International Court of Justice and we publish our Decree Over Mandate before these Witnesses; again, not to subject ourselves to these Courts, but to force their action and deny them any plausible deniability otherwise. They either do their jobs with honor or they stand bankrupt of any law or moral code.

We, The United States of America Republic, bring our demand for remedy for all Moorish Americans who have been mislabeled, mistreated, misled, defrauded, robbed and misrepresented as a result of the described criminality, including mischaracterization of their political status and improper probate of their estates. We, The United States of America Republic, similarly Decree Over Mandate and demand the return of all right, title, and interest owed to the Moorish American National's and to the American People and furthermore demand restoration of all right, title, and interest owed to our unincorporated National Republic: The United States of America Republic —free and clear of Odious Debt and Encumbrances;

The Holy Prophet Noble Drew Ali the Redeemer of the Moorish American people

Salvation from the states or circumstances that destroy the value of human existence or human existence itself. The word "redeemer" and its related terms "redeem" and "redemption" appears in the Bible some 130 times and is derived from two Hebrew roots: pdh and Thought

used to describe divine activity as well, they arose in ordinary human affairs and it is in this context in which they must first be understood. Pdh is the more general of the two, with cognates of related meaning in Akkadian. Arabic and Ethiopic. It belongs to the domain of commercial law, and refers to the payment of an equivalent for what is released or secured. The verb pdh, unlike Go'el, indicates nothing about the relation of the agent to the object of redemption, which in the Bible is always a person or another living being. Its usage does not differ in cultic activity from that of a normal commercial transaction. In both cases a person or an animal is released in return for money or an acceptable replacement (cf. Ex 13:13; 34:20; Lev. 27:27; 1 Sam. 14:45 with Ex. 21:7-8; Lev. 19:20; Job 6:23). Go'el is more restricted in usage and does not appear to have cognates in other Semitic languages. It is connected with family law and reflects the Israelite conception of the importance of preserving the solidarity of the clan. The Go'el ("redeemer") is the next of kin who acts to maintain the vitality of his extended family group by preventing any breaches from occurring in it. Thus he acquires the alienated property of his kinsman (Lev. 25:25) or purchases it when it is in danger of being lost to a stranger (cf. Jer. 32:6ff.)....

How Did Noble Drew Ali Redeem the Moor's

In 1781 the United States borrowed money from the king to fight the revolutionary war. They had 7 years to pay the debt back when they couldn't pay, a treaty was signed that created a creditor a debtor and an obligation that allowed others to have to pay the debt back namely the American people. When it was not paid the United States went bankrupt and the UNITED STATES federal government then took the Constitution and Re-ratified it in 1789 into a Constitution of the Corporate UNITED STATES. In 1859 the United States could have come out of debt but enlarged it to fight the civil war. The United States had another chance to come out of debt in 1929 but didn't instead they borrowed more money for farming and in 1933 filed bankruptcy a 2nd time. This time they pledge the American people for the debt. Thank ALLAH for the Prophet Noble Drew Ali who came in 1913 the same year the Federal Reserve was created. In 1928 he redeemed our Lands at the Pan American Conference in Havana Cuba and 1929 according to the Law of Jubilee 70yrs a nation can be redeemed. The Moorish American People were redeemed by Prophet Noble Drew Ali, a Pure and Free Nation. Thereby making all Moorish Americans Free Born Nationals with no Cloud on Title.

The United States of America Republic National Government is designated trustee in accordance with the manner in which the said trust was created. In other words, "a trustee may be indicated and assume responsibility as such without the express designation". 76 Am Jur 2d, Sec. 1 19, p. 362. That is one of the advantages of the trust institution, technical or particular words or phrases are not required or essential to the manifestation of an intention of a settler to create a trust. 76 Am Jur 2d, sec. 41, p. 287.

Knowledge of the Express Trust existence was reposed in the trustee the United States of America Republic National Government, enabling the National Government to act as trustee on behalf of the Beneficiaries, the Moorish American People. Thus the legal title vested in the United States of America Republic National Government. However, under Illinois law, legal delivery and vesting the legal title in the trustee in this particular case relates back to August 1, 1928 the date the instrument was deposited... Clark v. Clark, 183 111 448, 56 NE 82. See 23 Am Jur 2d, sec. 284, p. 318

("Where a deed is placed in the hands of a third person who is agent for the grantor alone, the delivery dates from delivery to the grantee, not from delivery to the agent, especially as between the grantee and a claimant of immediate right. On the other hand, where the deed was irrevocably deposited, ultimate delivery



to the grantee relates back to the time of the original delivery”) Also see 23 Am Jur 2d, Sec. 131, pp. 179-180.

(“Where the grantor delivers the deed to a third person with the intention that the title thereby pass to the grantee, but the recipient has no authority to receive the deed in behalf of the grantee, the grantee may ratify what was done in his behalf, and the imperfect delivery thereupon becomes complete and perfected”).

Therefore, by judicial interpretation, the vesting of the legal title in United States of America Republic National Government as Trustee, not only relates back to the date the Grantor, Prophet Noble Drew Ali, recorded the deed August 1, 1928, this appointment is made thereby by the Grantor himself. This is how the United States of America Republic National Government received this appointment as trustee directly from the Grantor, Prophet Noble Drew Ali, even though the United States of America Republic National Government was created on April 15, 2015.

## **THIS PUBLIC LAW IS TO BRING IN FULL EFFECT AND COMPLIANCE THE 14<sup>TH</sup> AMENDMENT**

**14<sup>TH</sup> AMENDMENT SECTION 1. THIS STATE SHALL HAVE THE POWER OF REPATRIATION; THE REPATRIATION OF COLOREDS, NEGROES, BLACK, AFRO-AMERICANS AND AFRICAN-AMERICANS BACK TO THE DIVINE CREED OF THEIR FOREFATHERS; BACK TO STATEHOOD, BACK TO THE CONSTITUTIONAL FOLD OF THIS FREE NATIONAL GOVERNMENT; BACK TO BEING MOORS, MOORISH AMERICANS, MOORISH NATIONALS, AND NATIONAL CITIZENS.**

**THE 14<sup>TH</sup> AMENDMENT SECTION 2. ALL NATIONALS AND CITIZENS OF THE UNITED STATES OF AMERICA REPUBLIC, UPON TAKING THE OATH OF ALLEGIANCE TO THE UNITED STATES OF AMERICA REPUBLIC, SHALL BE PARDONED OF ALL PAST CRIMES OF COLORABLE LAWS. THE UNITED STATES, OR SEVERAL STATES, SHALL NOT USE SUCH CRIMINAL RECORDS AGAINST A**




