

### <u>UNITED STATES OF AMERICA REPUBLIC, PROVINCE OF ILLINOIS</u> 19-April-2020

Pursuant to the United States of America Republic Constitution Amendment 19, Section 2, Clause 2, wherein it states; "The United States of America Republic shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States of America Republic, or any Department or Officer thereof", there shall hereby be designated "CONFLICT OF NATIONALITY OF MOORISH AMERICANS AND MOORISH AMERICAN CHILDREN" provisions to serve this purpose. This Executive Order shall go into immediate force.

Introduced as Executive Order 119-70, an Order was delivered by the President to Continental Congress of the United States of America Republic to honor and therefor to bring in full force Executive Order 119-70;

The Executive Order has now been entered into full force.

The 1st Continental Congress of the United States of America Republic now have 30 days of the posting and delivery of said order to contest, object, amend or suggest any changes to the Executive Order or forever ACQUIESCENCE. Upon having no recommendations by the Continental Congress The document known as Executive Order 119-70 was signed and enacted into law on 19 April 2020 by the President and reads as followed;

## EXECUTIVE ORDER 119-70 on 19 April 2020

The President, Is Authorizing and Ordering, To be proclaim and established EXECUTIVE ORDER 119-70 on 19 April 2020 and all its provisions in accordance with the Constitution and Laws of the United States of America Republic.

**CONSIDERING** that it is of importance to settle the issue on the Nationality of so called Negro, Blacks and African American people in America. There shall be no more questions relating to Moorish American people in America being Mislabeled as Negro. Black or African American, Is a violation of International Law and is a major injustice to the Aboriginal people of the Americas and a sin against humanity. It is unjust and a conflicts with nationality laws;

**BEING CONVINCED** that it is in the general interest of the Moorish American people of the United States of America Republic that all Negro, black, colored and African American people shall be this day forward and forever, are hereby Repatriated back to their National Government as Moorish American People in alignment with their forefathers National Descent and divine creed. The Moorish American people make their grievances known to the international community to secure this Right and that all its members should recognize that every person should have a nationality and should have one nationality only;

**RECOGNISING** accordingly that the ideal towards which the efforts of humanity Should be directed in this domain is the abolition of all cases both of statelessness and of double nationality, as well as allegiance to the United States. It should be known that the Nationals of America are the Moorish American people and the Moorish American Government is without doubt or contradiction is the United States of America Republic.

**BEING OF OPINION** that, under the economic and social conditions which at present exist in the various countries, it is not possible to reach immediately a uniform solution of all the above mentioned problems caused by slavery and colonization in our land "America"

**BEING DESIROUS**, nevertheless, as a first step toward this great achievement, of settling in a first attempt at progressive codification, those questions relating to the Moorish American people in America being labeled as Negro. Black or African American is a conflict of nationality laws on which it is possible at the present time to put an end to the denationalization,

## I HAVE DECIDED to CONVENTION ON CERTAIN QUESTIONS RELATING TO THE CONFLICT OF NATIONALITY LAWS IN AMERICA

I President Christopher H- Cannon: Bey concur with the Hague Conventions **Conflict of Nationality Laws** and have for this purpose issue Executive Order 119-70 to go into immediate force on behalf of the United States of America Republic.

**THE PRESIDENT** having deposited a full copy of the Executive Order with the Secretary of State the Executive Order full powers shall be found in good and due form, **AS FOLLOWS:** 

# CONFLICT OF NATIONALITY OF MOORISH AMERICANS AND MOORISH AMERICAN CHILDREN

Article 1

14<sup>th</sup> Amendment Naturalization of Moorish American parents conferred the nationality of a State and made Moorish Americans U.S. citizens (wards of the Federal government) and subject to the jurisdiction thereof. The 14th Amendment also secured the 1<sup>st</sup> through the 8<sup>th</sup> Amendment, 13<sup>th</sup>, 14<sup>th</sup> and 15<sup>th</sup> Amendment on such Moorish American parents and their Moorish American Children as, according to its law, are minors the nationality of the State by which the naturalization is granted.

In such case the law of that State may specify the conditions governing the acquisition of Its nationality by the minor Moorish American parents to that of Negro, Black, or African American which then affects the Nationality of Moorish American Children as a result of the naturalization of the parents by the 14<sup>th</sup> Amendment. In all future cases where minor Moorish American Children are born, Moorish American Children shall not acquire the State nationality of the Union States as did their parents as the result of the naturalization of the 14<sup>th</sup> Amendment, they shall retain their nationality as Moorish Americans.

## **GENERAL PRINCIPLES**

#### Article 2

It is for the United States of America Republic National Government to determine under its own law who are its Nationals. This law shall Be recognized by other States in so far as it is consistent with international Conventions, international custom, and the principles of law generally recognized with Regard to nationality.

#### Article 3

Any question as to whether a person possesses the nationality of Moorish American shall be determined in accordance with the law of the United States of America Republic National Government.

#### Article 4

Subject to the provisions of the present Convention, a person having two or more Nationalities may be regarded as it's national by each of the States whose nationality he Possesses. No Moorish American National shall possess two nationalities, but a citizen of foreign nationality who pledges their allegiance to the United States of America Republic National Government shall have no forms of Immunity from the State of whom nationality the citizen carries.

#### Article 5

The United States of America Republic National Government may not afford diplomatic protection to one of its citizens against a State whose nationality such person also possesses.

#### Article 6

Within a third State, a person having more than one nationality shall be treated as if he had only one. Without prejudice to the application of its law in matters of personal status and of any conventions in force, a third State shall, of the nationalities which any such person possesses, recognize exclusively in its territory either the nationality of the country in which he is habitually and principally resident, or the nationality of the country with which in the circumstances he appears to be in fact most closely connected. Moorish American Nationals shall be recognized as having only one Nationality.

#### Article 7

Without prejudice to the liberty of a State to accord wider rights to renounce its Nationality, a person possessing two nationalities acquired without any voluntary act on his part may renounce one of them with the authorization of the State whose Nationality he desires to surrender.

This authorization may not be refused in the case of a person who has his habitual and Principal residence abroad, if the conditions laid down in the law of the State whose Nationality he desires to surrender are satisfied. Moorish Nationality cannot and shall not be lost under no circumstances under the United States of America Republic outside of the laws of Expatriation.

**NOW, THEREFORE**, be it Resolved by the President of the United States of America Republic, The President has authorized and requested to designate the administration of said Executive Order.
