



UNITED STATES OF AMERICA REPUBLIC, PROVINCE OF ILLINOIS

12 March 2020

Pursuant to the United States of America Republic Constitution **Amendment 19, Section 2, Clause 2**, wherein it states; “**The United States of America Republic** shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States of America Republic, or any Department or Officer thereof”, there shall hereby be designated “**Policy Seat- Level Position**” provisions to serve this purpose. This Executive Order shall go into immediate force.

Introduced as Executive Order, a request was delivered by the President to honor and therefor establish protocols for our Policy Seat- Level Position.

The Executive Order suffered no amendments, no exclusions, and no demands, that it has now been entered into full force.

The 1st Continental Congress of the United States of America Republic publicly declared 2015 the national “Year of the United States of the United States of America Republic”. The document known as Executive Order 119-71 was signed and enacted into law on 12 March 2020 by the following SIGNATORIES to the Executive Order in Attendance;

EXECUTIVE ORDER 119-71 on 12 March 2020

The President, Authorizing and Requesting To proclaim and establish provisions in accordance with the Constitution and Laws of the United States of America Republic.

NOW, THEREFORE, be it Resolved by the President of the United States of America Republic, The President has authorized and requested to designate the administration of said Executive Order.

Policy Seat- Level Position

Section 1

A Moorish American National maybe eligible for a Policy Seat- Level Position only after completing their United States of America Republic citizenship application and state oath.

Section 2

Holding any Policy Seat- Level Position for example such as Head of State, Attorney General, Secretary of State, Governor, Speaker of the House, Senator, Representative, Public Minister, Chief of Staff, Judges, etc. in the United States of America Republic is incompatible with maintaining Nationality or Citizenship of any foreign State.

Section 3

Under international law, as applied in the United States of America Republic, a head of state, or Public minister for example (who is not a local national or citizen of any foreign State) enjoys absolute immunity from the criminal, civil and administrative jurisdiction of law of any other State, a status that is inconsistent with continued allegiance to any foreign State.

Section 4

Holding any Policy Seat- Level Position in the United States of America Republic is inconsistent with maintaining allegiance to any other State, only when the legal criteria and requirements are met then shall only a Moorish National be entitled and eligible for office, holding any Policy Seat- Level Position in the United States of America Republic.

Section 5

If the Moorish American did not complete the legal criteria and met the requirements, and with intent to loose, relinquish, or expatriate their nationality or citizenship of any foreign State, he or she shall not hold any Policy Seat- Level Position in the United States of America Republic.

Section 6

Amendment XIV section 1. This State shall have the power of repatriation; the repatriation of coloreds, negroes, black, afro- Americans, and African- Americans back to the divine creed of their forefathers; Back to Statehood, back to the Constitutional fold of this free National Government, Back to being Moors, Moorish Americans, Moorish Nationals, and National Citizens.

Section 7

Immediately after this Law goes into effect, whoever has not completed and submitted their legal packet to the Chief of Staff will be removed from their Policy Seat-Level Position, within 14 days after this Law goes into effect.

Therefore the United States of America Republic National Government, USAR protocols for Policy Seat-Level Positions shall improve customarily procedures in government administration in placing Citizens in positions of Trust.

NOW, THEREFORE, be it Resolved by the President this Executive Order 11987 the United States of America Republic, that the President is authorized and designated to the administration of said law and Establishes the Protocols for our Policy Seal-Level Position to maintain a criteria required to take a National Seat. In this Government to ensure that each person is giving their trust, sole allegiance and fidelity being National Citizens of the United States of America Republic. As President I authorize the Full Enforcement of the Protocols(s) for our Policy Seat-Level Position as a requirement prior to taking any Policy Level Seat in the United States of America Republic. Therefore add to the requirements to fulfill this obligation prior to taking seat in this National Government. To uphold the duties set forth in each position as trustees to the Moorish America People and Citizens of the United States of America Republic
