Honorable Secretary Pompeo,

As the Secretary of State of the UNITED STATES OF AMERICA REPUBLIC, I am committed to ensuring good business, welcoming positive relations conducted between nations, and also reminding parties of the contractual agreement in place. No state shall impair the obligations of contracts or regulate commerce of foreign nations. Moorish American People have clearly benefited from having our own government. The UNITED STATES OF AMERICA REPUBLIC established a Department of State, Bureau of Motor Vehicles, Secretary of State, Department of Justice, Office of Attorney General, Courts, Department of Vital Statistics, etc. This is a clear indication of the type of commerce being conducted as a nation of people.

Importantly, the charter of the UNITED STATES OF AMERICA REPUBLIC can be viewed by conducting a business search at the State of Indiana website. (https://inbiz.in.gov/BOS/Home/Index)

It is of the up most importance that the Nationals and Citizens of this state are given the same Privileges and Immunities as citizens in other states. Full Faith and Credit must be given to public Acts, Records, and judicial Proceedings of every other State. Any one who takes an oath are bound by article 6 to uphold the constitution and laws of any state to the contrary notwithstanding. Undoubtedly productive diplomatic relations makes our nations stronger.
