



UNITED STATES OF AMERICA REPUBLIC, PROVINCE OF ILLINOIS

1 April 2020

Pursuant to the United States of America Republic Constitution **Amendment 19, Section 2, Clause 2**, wherein it states; “**The United States of America Republic** shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States of America Republic, or any Department or Officer thereof”, there shall hereby be designated “**Utility Nationalization**” provisions to serve this purpose. This Executive Order shall go into immediate force.

Introduced as Executive Order 119-68, a request was delivered by the President to honor and therefor establish “Utility Nationalization”.

The Executive Order has now been entered into full force.

The 1st Continental Congress of the United States of America Republic publicly declared 2015 the national “Year of the United States of the United States of America Republic”. The document known as Executive Order 119-68 was signed and enacted into law on 1 April 2020 by the following SIGNATORIES to the Executive Order in Attendance;

EXECUTIVE ORDER 119-68 on 1 April 2020

The President, Authorizing and Ordering, to proclaim and establish provisions in accordance with the Constitution and Laws of the United States of America Republic.

NOW, THEREFORE, be it Resolved by the President of the United States of America Republic, The President has authorized and requested to designate the administration of said Executive Order.

U.S.A.R. UTILITY NATIONALIZATION

Section 1

The U.S.A.R. UTILITY NATIONALIZATION shall be implemented immediately for the preservation of the Moorish American People of the United States of America Republic.

Section 2

Nationalization refers to when a government takes control of a company or industry, which generally occurs without compensation for the loss of the net worth of seized assets. Colonization has robbed the Moorish American People of potential income being taken for centuries through colonization. The Moorish American People of the United States of America Republic has sole ownership rights to all natural resources and a right to revenue generated by such sources. Natural Gas, Water, Electricity, Agriculture, Oil, Gold, Silver, and any other minerals obtained from the Land. In the United States of America Republic colonist owned or controlled utility companies is incompatible with maintaining control of mineral rights belonging to the Moorish American People.

Section 3

Nationalization of some **important** industries would enable the United States of America Republic to earn large revenue easily and without any extra cost. Control over prices of war supplies: During war, **nationalization** would help because the United States of America Republic being the National Government and the Moorish American People being the National Citizens could not be forced to pay exorbitant prices for war supplies by a handful of war profiteers.

Section 4

May Affect employment within those services that private companies are likely to terminate due to unprofitability, the number who departed their posts in 2018 is the highest annual total since 2008, when the financial crisis hit. The high level of departures is in part because companies are concerned about the outlook for the economy and markets.

Section 5

More than 1,000 CEOs stepped down during the first three quarters of Dec 23, 2019 according to a report published by the staffing firm Challenger, Gray, & Christmas — 1,160 executives, to be exact. A CEO stepping down from their role might cause panic and confusion. ... Additionally, CEOs are often viewed as the core of a business, and changes in upper management often lead to upset and depression among staff.

Section 6

Amendment XIV section 1. This State shall have the power of repatriation; the repatriation of coloreds, negroes, black, afro- Americans, and African- Americans back to the divine creed of their forefathers; Back to Statehood, back to the Constitutional fold of this free National Government, Back to being Moors, Moorish Americans, Moorish Nationals, and National Citizens.

Section 7

The corporate democracy, which is the United States, has been under the control of a very small group of private corporations and privateers for far too long.

Oil, Gas, Coal, Electricity and Water are all controlled by a small oligopoly of privately-owned companies, many of whom have such a firm grasp on regional markets where they near a monopoly, especially when it comes to water and electricity.

Public necessities such as electricity and water should not be for-profit. Neither should be the corrupt fossil fuel industry which consistently puts public safety at risk through resisting climate change reform by sowing doubt in the public discourse.

The incentive structure of the privately owned fossil fuel industry encourages promoting phony "research" which denies climate change. They also incessantly lobby congress and donate campaign contributions to politicians to block climate change reform or halt the debate on the issue by giving off the perception that climate change evidence is inconclusive. Mineral rights and retain their surface rights, they lose control over what actually happens on their land. ... This is irregardless of the surface rights held by the original property owner.

Therefore the United States of America Republic National Government, U.S.A.R. UTILITY NATIONALIZATION shall

NOW, THEREFORE, be it Resolved by the President this **Executive Order 11987** of the United States of America Republic, That the President is authorized and designated to the administration of said laws and Establishes the Moorish Marshal's as a Law Enforcement Agency for the Policing of Law Enforcement to rid Law Enforcement Agencies Nationwide of Corruption and Racism. To investigate their Unions and The Fraternal Order for Rico Acts committed under a veil of Justice covering up criminal Activities committed by Law Enforcement Officers. As President I grant the Full Power and Authority of The United States of America Republic to the Moorish Marshal's and therefore add to their Current duties to fulfill this obligation to the Moorish American People and citizens of the United States of America Republic.
