

<u>UNITED STATES OF AMERICA REPUBLIC, PROVINCE OF ILLINOIS</u> 06/06 June 2020

Pursuant to the United States of America Republic Constitution Amendment 19, Section 2, Clause 2, wherein it states; "The United States of America Republic shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States of America Republic, or any Department or Officer thereof", there shall hereby be designated "Morocco Treaty of Peace and Friendship of 1787 which was superseded in 1836 Now in Full Force 2020" provisions to serve this purpose. This Executive Order shall go into immediate force.

Introduced as **Executive Order 119-75**, a request was delivered by the President to honor and therefor establish protocols for our "**Morocco Treaty of Peace and Friendship of 1787 which was superseded in 1836 Now in Full Force 2020**".

The Executive Order suffered no amendments, no exclusions, and no demands, that it has now been entered into full force.

The 1st Continental Congress of the United States of America Republic publicly declared 2015 the national "Year of the United States of the United States of America Republic". The document known as **Executive Order 119-75** was signed and enacted into law on 6 June 2020 by the President. The Executive Order has been delivered to the Secretary of State in Attendance;

EXECUTIVE ORDER 119-75 on 6 June 2020

President, Authorizing and Requesting To proclaim and establish provisions in accordance with the Constitution and Laws of the United States of America Republic.

NOW, THEREFORE, be it Resolved by the President of the United States of America Republic, The President has authorized and requested to designate the administration of said Executive Order 119-75.

BODY OF LAW

To all Persons to whom these Presents shall come to be made known;

The Morocco Treaty of Peace and Friendship of 1787 which was ratified in 1836, between Moorish and Christian Powers are the longest unbroken treaty to which the United States is party. This treaty is between Moorish Powers, their ancestral successors, and foreign Christian Powers. Not to be confused with the Moroccan Citizens inhabiting North Africa, this was under French and Spanish Control up until 1956. The original inhabitants of Morocco were of Moorish descent. Morocco/ the Great Maghreb al Aqsa, is North America and heartland of the Moorish Empire.

The Original Flag of Al Moroc or American Flag is The Moorish Flag, which is over 10,000 years old. The Moorish Flag is a red flag with a five-pointed green star in the center that represent love, truth, peace, freedom, and justice which are the highest principles known to man. The Moorish Flag also known as the American Flag is The National Flag of The Moorish American People who are the National Citizens of the United States of America, who maintain a National Republic form of Government.

The Moorish American flag was returned back to those of Moorish decent in 1913 by Head of State and Prophet, Noble Drew Ali. The Moorish flag/American Flag is different from the Kingdom of Morocco flag which has a green interlaced pentangle, red background, representing, hardiness, bravery, strength and valor, while the green represents love, joy, wisdom, peace and hope, the color of Islam, seal of Solomon and five branches or pillars of Islam.

Even Though these two flags are similar in nature they are not. The Moorish National Standard of the Moorish American People of The United States of America Republic represent a people of Moorish descent, the Kingdom of Morocco Flag does not. We as the Moorish American people claim our original inheritance and enforce all the provisions provided by the original Treaty of Peace and friendship of 1787 between Moorish and Christian powers. Superseded by the Treaty of Peace and Friendship of 1836.

Kingdom of Morocco, but still reflect protections for Moors. To this date the Moroccan Citizens of the kingdom of Morocco do not refer to themselves as Moorish or Moors.

There are no records or proof that exists of the Moorish American People ever expatriating their citizenship to Morocco.

The Inheritance, provision, and position were never abandoned by original Moors or their ancestral successors the true Mocrish American Nationals who are descendants of Moroccans born in America.

The United States of America Republic and its Moorish American Nationals and Citizens are the true ancestral successors of the U.S.A. / Morocco Treaty of Peace and Friendship. WHEREAS, I Christopher H- Cannon: Bey President of the United States of America Republic Demand that the United States honor all Treaty Agreements and other Constructive arrangements made by Our States according to their Original Spirit and intent concluded by their successors.

I Christopher H- Cannon: Bey President of the United States of America Republic fulfills my duties to interpret and apply international law, for the purposes of the executive power to conduct the nation's foreign relations and constitutional powers of the United States of America Republic National Government.

Be It Resolved, June 7, 2020 I Christopher H- Cannon: Bey President of the Moorish Powers, I have hereunto set my name, and caused the seal of the United States of America Republic to be affixed to the Peace and Friendship treaty of 1787 superseded by The Peace and Friendship Treaty of 1836. I invoke the Peace and Friendship treaty of 1787 superseded by The Peace and Friendship Treaty of 1836 with the gracious favor of the Creator of the Universe.

Done at the City of New Mecca Province of Illinois, this twenty-fifth day of June, 2020 and of the Independence of the United States of America Republic. To be published to the world. The Moorish American people are a people of peace.

The President has Ordered into Full Force the Peace And Friendship Treaty 1787/1836/2020 "Is Now In Full Force" signed by President Christopher H- Cannon: Bey the United States of America Republic bringing into full force, The Peace And Friendship Treaty 1787 superseded in 1836 is now Superseded by this Executive Order June 6, 2020. President Christopher H- Cannon: Bey "Head of State" Nunc Pro Tunc, The Peace and Friendship Treaty 1787 superseded in 1836 with the Great Seal of the United States of America Republic and it shall be superior to any prior issued by any before. President Christopher H- Cannon: Bey the United States of America Republic certify under penalty of perjury without the UNITED STATES under the laws of the UNITED STATES OF AMERICA REPUBLIC pursuant to Article 6 U.S. Constitution which states;

"All Debts contracted and Engagements entered into, before the Adoption of this Constitution, shall be as valid against the United States under this Constitution, as under the Confederation.

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any state to the Contrary notwithstanding.

All Moorish Americans are now under the protections of the Peace and Friendship Treaty of 2020. The United States of America Republic Reserves all Rights over her Nationals and Citizens as well as over all American Natives, those classified as such and those not classified as such.

Legal Notice is hereby given:

§2381. Treason

Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, is guilty of treason and shall suffer death, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the United States

No man or organization in this country is above the law and No officer of the law shall set any law at defiance with impunity, all the officers of the Government from the Highest to the lowest are creatures of the law and our bound to obey it. God Bless The United States of America, and Long Live The Republic.
